



PUBLIC NOTICE

To all interested persons having the right to sign a request for participation in a referendum.

Following a public consultation assembly held on March 21st, 2015, the council adopted the second draft By-Law **2015-02**, on April 7, 2015 modifying the zoning by-law to add the following commercial establishments: animal Lodging, Sales of animal products and veterinary clinic in the C2 category to the uses permitted in zones **P-115, P-124, P-144, U-203 and U-200**.

This second project contains provisions which may be the subject of a request on behalf of all interested persons that the by-law in question, is subject to the approval of residents that may vote in accordance with the ***Law on elections and the referendums in the Municipality***.

The information to determine which interested persons entitled to sign the register may be obtained at the office of the municipality, between 8 am to 4 pm, Monday to Friday. A copy of the summary of the second project can be obtained or consulted free of charge by any person who requests it.

The register will be available April 23, 2015 from 9:00 a.m. to 7:00 p.m. at the municipal office, 30 Begley Road, Kazabazua, Quebec.

The persons to whom this may concern has the right to request that the by-law be submitted to a referendum poll, by entering his name, address and capacity, together with his signature, in a register open for that purpose.
